

Terms & Conditions

For the #OccupationOfTheDay Christmas Quiz, December 2023

The **Promoter** is defined to be Sophie Kay of *The Parchment Rustler* genealogy blog.

A **Participant** is defined to be any individual who submits their two-word Christmas phrase formed by the answers to the quiz questions, along with their contact details, in accordance with the terms and conditions detailed below.

1. Participants must be aged 18 or over.
2. The Prize Draw opens at **8:00am GMT on Friday 22nd December 2023** and closes at **11:59pm GMT on Friday 5th January 2024**. Entries submitted after the closing date will not be valid.
3. The prize is one (1) paperback copy of "Vagabonds" by Oskar Jensen, published by Duckworth Books. The prize is non-transferable and cannot be exchanged for equivalent cash value.
4. No entry fee is required at any stage.
5. A Participant will be allocated one ticket in the Prize Draw if they submit the correct answer.
6. Participants who submit an incorrect answer will not be included in the Prize Draw.
7. A Prize Draw will be carried out during January 2024 after the closing date, selecting one ticket at random under observation from an independent party. The Participant whose ticket is selected will be deemed to be the Prize Winner.
8. Only one entry per person is permitted. Multiple entries from the same person but under different email addresses are not allowed. In the event of any person attempting to submit multiple entries, the Promoter reserves the right to remove all that person's entries from the Prize Draw.
9. This Prize Draw is open to participants resident in any nation. Participants agree to be bound by these terms and conditions under the laws of the United Kingdom. The prize will be posted from the United Kingdom in January 2024; should the Prize Winner be resident outside the United Kingdom, they, and not the Promoter, are responsible for the payment of any import duties or taxes which the prize parcel may incur. The Promoter will not be held liable for any such additional charges.
10. The Promoter cannot be held liable for any delays in delivery arising from issues within local or international postal systems.
11. The winner will be notified by email by **11:59pm GMT on Wednesday 31st January 2024**. If the chosen winner fails to respond in order to claim their prize within seven calendar days of the date of the notification email, their win will be deemed null and void and the Promoter reserves the right to select a different winner.
12. Proof of age may be required from the winner prior to dispatch of their prize.
13. The winner agrees to have their name, state or county, and country of residence publicised on *The Parchment Rustler* and associated social media channels in order to announce the conclusion of the Prize Draw.
